### International Day of Action for Trans Depathologization 2016

STP, International Campaign Stop Trans Pathologization

The **International Day of Action for Trans Depathologization** 2016, convened by STP, International Campaign Stop Trans Pathologization<sup>1</sup>, takes place today, on Saturday, October 22, 2016. Over 220 actions for trans depathologization<sup>2</sup> were organized today and throughout the entire month of October in 47 cities of different world regions, including international activities, under the slogan "*Stop Pathologizing Gender and Bodily Diversity*". This year, we observe the participation of many new groups, as well as the ongoing support of groups, organizations and networks that have participated for years in the call to action for the International Day of Action for Trans Depathologization. Furthermore, to this day 410 activist groups and networks, public institutions and political organizations in Africa, Asia, Europe, Latin America, North America and Oceania, as well as numerous individuals, have declared their support for STP, International Campaign Stop Trans Pathologization<sup>3</sup>.

Currently, trans depathologization activism continues to focus on the **revision process of the International Statistical Classification of Diseases and Related Health Problems (ICD)**, which is published by the World Health Organization (WHO). The expected approval date of ICD-11 by the World Health Assembly is 2018<sup>4</sup>.

As noted in previous press releases<sup>5,6,7</sup>, we believe that the removal of trans-specific categories from the '*Mental and behavioural disorders*' Chapter and the inclusion of a trans-specific

category in the 'Conditions related to sexual health' Chapter in the ICD-11 Beta Draft<sup>8</sup> is an important advancement.

However, we are concerned about the continued **diagnostic classification of gender diversity in childhood** in the ICD-11 Beta Draft, by means of the '*Gender incongruence of childhood*' code. We believe that children with gender expressions and identities that differ from their gender assigned at birth do not require a diagnostic category, but an environment open to gender diversity, including fluid and non-binary options. In order to ensure access to psychological support services for children, parents and other community members, we suggest the use of so-called Z codes (codes in the 'Factors influencing health status and contact with health services' Chapter)<sup>9,10</sup>. Over the last few years, several international<sup>11,12,13,14,15,16,17,18,19</sup> and

regional<sup>20,21,22,23</sup> activist networks, as well as individual authors<sup>24,25,26,27</sup> have contributed arguments against the diagnostic classification of gender diversity in childhood in various declarations, reports and papers. To this day, 227 health professionals and researchers have signed a declaration supporting the removal of the diagnostic code '*Gender incongruence of childhood*'<sup>28</sup>. The European Parliament recommends its removal in recent strategic documents<sup>29,30</sup>.

Furthermore, we recommend that the WHO continues working on the **terminology and approach** used in the new code '*Gender incongruence of adolescence and adulthood*' in order to avoid the implied psychopathological bias of the term '*Gender incongruence*'. As mentioned in previous reflection documents and press releases<sup>31,32,33</sup>, we strongly suggest the use of a descriptive terminology for the code related to gender transition-related body modification processes in adolescents and adults, such as '*Health care related to gender transition*'.

Therefore, we demand that the WHO **removes the 'Gender incongruence of childhood' code from the ICD-11 Beta Draft** and works on a **non-pathologizing and descriptive terminology** for the code related to gender transition-related body modification processes in adolescents and adults.

We celebrate recent advancements that have taken place regarding **legal gender recognition processes**. Following the precedent of the Argentinian Gender Identity Law<sup>34</sup>, gender recognition laws without medical requirements have been approved in Denmark<sup>35</sup>, Malta<sup>36</sup>, Colombia<sup>37</sup>, Ireland<sup>38</sup> and Norway<sup>39</sup>. These laws establish a new standard to be followed in terms of legal gender recognition. However, in many countries throughout the world, legal name and gender marker changes are still illegal, pending on Court processes or subject to requirements such as diagnosis, hormonal therapy, genital surgery, sterilization and/or divorce, thus violating the right to recognition before the law and the right to bodily integrity.

For this reason, we demand the **modification of existing gender identity laws** and the **approval of new laws** in order to facilitate **gender recognition processes without medical requirements or civil status requisites**.

Finally, we remain concerned with the **ongoing situation of transphobic violence** directed towards trans people in different world regions. We are immensely saddened by the continuous news of transphobic hate crimes. In addition to street violence, we note **institutional violence, mistreatment, pathologization and discrimination** directed at trans people in the administrative, educational, health care and legal contexts.
